SAFETY COMMITTEE REPORT TO NEIGHBORHOOD COUNCIL AUGUST 27,2003

Recap:

After completion of REACT training and the subsequent demonstratic and certification this past April, funding and direction of the safety REACT program by the RFD was suspended by the city manager. After citizen lobbying REACT has been reinstated under the RPD.

Last Wed. Ms. Kathy Gerk, Emergency Services Manager of the City of Richmond met with the Point Richmond Safety Committee the REACT trainees our next tasks:

- REACT Follow Up Actions (to include team leader assignments and locating centers for Command, First Aid, Shelter, Communications, and Evacuation.)
- Disaster Forms (including Family Registry, Neighborhood Disaster Plan, Neighborhood Leaders and Team Locations, Skills and Equipment Resource Log).
- Communications Plan, which will be implemented once the above fulfilled. Th
 will include free CB radios and training for the Safety Committee.

These steps will assist the REACT trainees to attain our next goal of organizing disaster preparedness for the neighborhoods of Point Richmond. Kathy Gerk als made the following points:

- She will attend the next PRNC meeting, Sept. 24.
- The county has received a Federal grant to train RPD officers as REACT trainers.
- She will contact teen volunteer groups with the fire and police dept's to explore assisting in organizing community participation with REACT.
- She will explore regular first aid training, such as "First Response", for Pt.
 Richmond residents.

- REACT will contact Neighborhood Watch who will assist in organizing neighborhoods—currently on medical leave.
- On the last Sunday in October (28th), there will be a countywide "Shelter-i Place drill.

The REACT Director will contact other REACT groups to join us and other Richmond groups to facilitate networking. The next Safety Committee meeting will be 7:00 p.m., Sept. 10 at the Red Pepper.
